## CFI REINSTATEMENT RECOMMENDED PREPARATION

Determine which Reinstatement Test Type you want to be tested on.

Either of these three test types can be used as a basis for your Reinstatement, as long as you hold the specific Rating.

CFI - Private and Commercial Certification

CFII - Instrument Rating Add On

MEI - Multi Engine Rating Add On

If you only hold the CFI, then the specific additional Rating (MEI or CFII) you desire can be tested, and that test will automatically renew all other CFI Certificates held while also adding a new Flight Instructor Rating.

Enroll and Complete an FIRC Course.

Example: American Flyers FIRC Online Course – a one-time fee for lifetime recurrent usage.

Acquire a Syllabus – The Backseat Pilot, ASA, or etc.

Be proficient in the aircraft used for the test. Consider flying with a local CFI to regain flight proficiency in same type aircraft you plan to use for your Reinstatement Test.

Be able to demonstrate instructional knowledge in all areas included in the required Areas of Operations included in the Flight Instructor PTS.

Be able to fly and teach all required lessons.

Be able to develop and answer Scenario Based Questions regarding realistic scenarios likely experienced as a CFI.

Establish an IACRA Account.

Submit an Application for your Reinstatement in IACRA.
